#### **Polling District and Polling Place Review 2023**



The Polling Review is based on the current arrangements from the previous Polling District and Polling Place Review that came into effect on 1 February 2020, the proposals outlined in the most recent Interim Polling District Review conducted in July 2023 and the revised amendments to Parish boundaries following the Community Governance Review in July 2023 which will come into effect for Stroud District and Parish Council Elections in May 2024.

The electorates figures used for this Review are based on the 1 October 2023 electoral register. It is also worth noting that the electorate is the total electors for the polling station and includes those who have a postal vote in place.

CHC – At the Interim Polling District Review that took place in July 2023, it was identified that the Chalford Hill Methodist Church had been closed and therefore an alternative venue was located for the electorate of this polling district. It was proposed as part of this review that Chalford Sports and Social Club replace Chalford Hill Methodist Church. No objections were received as part of this consultation, however an alternative venue of France Lynch Church Rooms was proposed by respondees advising the location was more central within the polling district and closer to the majority of the properties within that polling district. Following the closure of the interim polling district review consultation a visit to the venue was undertaken to check its suitability. The France Lynch Church Rooms is in a good location for local electors as it is more centralised within the polling district. Disabled access is good with an appropriate ramp and hall size large enough for the population due to vote at this polling station. Parking is limited to on-street only however the venue has advised that they could provide cones from the Church to ensure disabled parking is available outside and could leaflet the immediate houses ahead of an election. Despite the on-street parking, the electorate size and locality of the residents to the venue, we do not envisage this to cause any issues on polling day. We therefore agree that France Lynch Church Rooms should be allocated as the Polling Station and Poll cards would be amended accordingly to advise electors of the new location.

HI - The recent Community Governance Review proposed the creation of a new parish called Great Oldbury to recognise the significant development in the area and support community cohesion and identity in the growing community. A full consultation was undertaken with the residents on the proposal to move into this new Parish. The new boundary will incorporate the transfer of land from HI Standish, SE Eastington, STA Stonehouse (North Ward Div 1) and STC Stonehouse (South Ward) into SF Great Oldbury. The Local Government Boundary Commission for England has also agreed to make the Parish and District ward boundaries coterminous.

It was also agreed at the Community Governance Review that a further review of the Great Oldbury and Standish boundaries could be undertaken once parcel PS19a had been developed, this would require the polling districts to be further altered at a future review. The new boundary incorporated the transfer of 130 properties from STA Stonehouse (North Ward) and transfer of land only from the STC Stonehouse (South Ward) into SF Great Oldbury. At the interim Polling District Review it was proposed that the polling district boundary be

amended to reflect the change in the parish boundary for Stonehouse and create the new parish boundary for Great Oldbury. No objections or additional proposals were received as part of this consultation to object to aligning the boundaries.

The Local Government Boundary Commission for England (LGBCE) has agreed to make the Parish and District ward boundaries coterminous.

**STA & STAA** - On the basis that the LGBCE could have rejected the proposal to make the boundaries coterminous a new polling district STAA (North Ward Div 2) was proposed as part of the interim polling district review. As the LGBCE has now agreed to make the boundaries coterminous we are proposing that the polling district boundaries are amended and that STAA (North Ward Div 2) is not created and STA (North Ward) has Div 1 removed from its title.

STC – At the Interim Polling District Review we proposed that Bethel Church replace the Stonehouse Community Centre however we received a handful of consultation responses asking us to reconsider the Stonehouse Community Centre due to a number of different reasons. Following the closure of the interim review consultation we visited the Stonehouse Community Centre in order to fully assess the accessibility provision of the station following the responses received. The Stonehouse Community Centre provides good parking facilities and good accessibility for disabled electors we therefore agree with the consultation responses and wish to move the Polling Station back to Stonehouse Community Centre. We are also aware that this polling station falls outside of the polling district in terms of its locality, however there is no other suitable venue within the polling district and therefore the Community Centre is the closest venue located adjacent to the boundary.
