#### 1. Introduction

1.1 This Statement of Modifications sets out the proposed modifications to the Council's Draft Charging Schedule (DCS) including Indicative Draft Regulation 123 List of infrastructure which were consulted upon in April-June 2016. The statement has been made in accordance with Regulation 19 of the Community Infrastructure Levy Regulations 2010 (as amended).

- 4.1 Table 1 below sets out the Council's proposed modifications to the DCS since it was made available during consultation and the reasons for these modifications being made.
- 4.2 No changes to the DCS itself are proposed. The modifications all relate to the Indicative Draft Regulation 123 List, included in the DCS at Annex 2.
