		I believe that if land is allocated within Stroud District to meet the housing needs of Gloucester City, then this number should be deducted from, rather than additional to, the numbers being forced upon Stroud District Council.

2.4 b		Rather than being an added extra, green infrastructure networks need to be planned into new developments from the beginning before other factors such as road networks are fixed. These networks need to be at different levels (water course, ground and above ground), and garden fences should be permeable to hedgehogs and other small animals. Green infrastructure should also be located to reduce pollution from roads and be managed to enhance biodiversity and bioabundance (e.g. infrequent mowing)

	and to sequester carbon (planting trees).
