Project Name: 1.Repair to Church Lychgate Walls 2. Re inscription of Memorial within Lychgate which commemorates residents of Hardwicke who died during the two world wars Project Location: Hardwicke Church, Church Lane Hardwicke

Brief Description: The Lychgate was originally erected in 1920 to commemorate people from Hardwicke who died during the first world war. Over the years the stonework and tiled roof have become worn and much repair was needed. The inscriptions on the two panels recording local people who gave their lives during the two wars had faded over the years and were hard to read the names. The inscriptions were re inscribed

Has the project been successful? The Lychgate has an historic value and important to maintain within the community. A local resident has researched the gate's history

Neighbourhood CIL Project

January 2024 In response to requests from residents the Parish Council pursued traffic restriction orders at five locations The Cost of the project was £15,000

£12,500 was funded through and the balance of £2,500 was funded through the County Council

The traffic order process is continuing and has led to widespread community consultation. It is expected that the orders will be completed by end of January 2025.

Neighbourhood CIL Project

Hardwicke Village Hall has been developing two projects; one is to develop a community café at the Village Hall and the second is to undertake internal alterations to provide a shared office space for the Village Hall. The Parish Council has a shared space within the office facility and for this the council also pays a monthly rental.

The project continued into 2024 financial year.
