I **OBJECT** to this proposed site, PS37, at Wisloe.

I live in the parish of Slimbridge which is a small parish of 500 houses. The proposed Wisloe site is for 1500 – 3 times the size of our village. This will join the village with Cam where there are already 1000s of houses being built. This will destroy the village and turn it into a huge town. Slimbridge is also home to the Wildfowl & Wetlands Trust – the largest international wetland charity in the UK. Allowing 1500 houses so close to this important site will

affect this wetland habitat.

Flooding and sewage – I have lived in the parish for over 40 years and have seen the River Cam flood and have had, and still have, problems with our sewage system. This site will only make things worse.

Traffic – the A38 is already extremely busy. Wisloe, together with the developments at Cam, will only make this worse. There is no employment locally so everybody will use cars to go to work. There is no safe route to walk or cycle to the small railway station at Cam.

The proposed site is on some of the **best agricultural** land (grade 2). It has a high pressure gas pipeline running through it and is situated between the M5, A38 and the railway – the noise and pollution from this is not a good environment to raise children.
