The proposed Wisloe development is in conflict with SDC's commitment to carbon neutrality by 2030, due to an increase in domestic and transport emissions and by impacting agricultural land.

False evidence has been used to declassify the site and, while SDC has accepted this, no action has been taken to correct the classification. Correction to ALC Grade 2 is urgently required, giving this land protection from development.

The proposed development on greenfield land along the A38 corridor will have the effect of severely altering the nature of the area, changing and almost unifying Cam and Slimbridge village (Tier 3b). This will approach urban sprawl, while Stroud is designated a Rural District.

The proposed site will spoil views in and out of the Cotswold and Forest of Dean AONBs in contrast to SDV's commitment to protect these areas and views. It will destroy the peace of the area and will negatively affect tourism, reducing the viability of local businesses. It will reduce the amenity value of the area and result in more people being crammed into smaller green spaces for recreation. This in turn will devastate natural habitats and reduce air quality.

There are no credible proposals to provide the infrastructure necessary for such a huge influx of new residents. Essential funding is not identified. Note the failed Homes England Bid. Longer traffic queues and lack of/overcrowded facilities will erode the desirability of the proposed housing, as well as affecting the amenity vale for existing residents, impairing their quality of life.
