I do not think the plan is sound because:- 1) it ignores the impact of upwards of 150 extra cars residing in Minchinhampton, plus the extra traffic required to service the needs of the proposed 80 new houses. (Despite what the planners say, most family houses these days have two cars, especially in Minchinhampton where public transport is negligible). All this extra traffic will funnel through a T junction on to the top of Butt Street. There it will either turn left into Minchinhampton Town centre or right into another T junction to join the Cirencester Road. Minchinhampton town centre is already overfull with traffic. Inadequate parking, narrow streets, delivery lorries and buses cause regular and dangerous grid locks in the centre and on the approaches. Additional traffic will exacerbate this. If the traffic turns right onto Butt Street there will be the two T junctions very close together. That, combined with the ever-increasing traffic load on the Cirencester Road, will cause tail backs down Butt Street and dangerous congestion at Blue Boys corner.

2) There has been no local consultation on the access via the Bulwarks to Butt Street. If there had been the points made above would have been immediately apparent.
