Section 37 – Use of Premises

A person commits an offence if he/she uses premises, or causes or permits premises to be used, to –

Provide facilities for betting (whether by making or accepting bets, by acting as a betting intermediary or by providing other facilities for the making or accepting bets).

Does not apply in relation to the use of a track by a person for accepting bets if the use is authorized by a premises licence (whether or not held by him/her)

A person guilty of either of the above shall be liable on summary conviction to-

- Imprisonment not exceeding 51 weeks,
- A fine not exceeding level 5 on the standard scale, or
- Both.

Section 39 - Occasional Use Notice

A person who accepts bets on a track, or causes or permits premises to be used for the acceptance of bets, does not commit an offence under section 37 if –

- A notice has been given under this section in respect of the track, and
- The activity is carried on in accordance with the notice.

A notice under this section (an "occasional use notice") in respect of a track may be given only by a person who is –

- Responsible for the administration of the track, or
- An occupier of the track.

An occasional use notice must -

- Be given in writing to the Licensing Authority for any area which the track is wholly or partly situated, and
- Be copied to the Chief of Police for any area in which the track is wholly or partly situated. (For all tracks within Stroud District use the address below)

An occasional use notice may not be given in respect of a track for a day in a calendar year if eight occasional use notices have be given in respect of that track for days in that year.

And

 A reference to a chief officer's area is a reference to the area in respect of which he/she has responsibility under that Act.
