Cam and Dursley Cluster				
The focus on jobs and services in the southern part of the district at the First-Tier settlement of Cam and Dursley is supported. The provision of new homes will help to support economic growth and will reduce in-commuting as a range and choice of new homes are provided for the 'area's skilled and trained workforce'.				
It is noted that:				

"Cam and Dursley are adjacent settlements and their combined population (14,800+) makes this a really significant conurbation and an important second focus for the district."

"Cam and Dursley have the best access to key services and facilities of anywhere in the District."

The strategy acknowledges that there are limited opportunities for Dursley to grow, due to landscape and environmental constraints around the town, including the proximity of the AONB. Consequently there is more of a focus for strategic growth at Cam, which is the second largest settlement in terms of population after Stroud.

The Settlement Strategy notes that Cam is relatively unconstrained by environmental, topographic or physical obstacles. Strategic growth offers some opportunities to bring about coordinated improvements to accessibility, connectivity and public transport as a direct result of development. The preferred direction for housing growth in landscape terms is to the north/north east and east of the settlement, this approach is supported.

The guiding principles for growth/development in the Cam and Dursley cluster – set out on page 120 of the Pre-Submission Plan are supported.


