Policy ES7 -Landscape Character

Policy ES7 states:

Within the Cotswolds Area of Outstanding Natural Beauty (AONB), or on land that may affect its setting, priority will be given to the conservation and enhancement of the natural and special qualities of the AONB, including landscape quality / landscape beauty, tranquility; dark skies; natural heritage and cultural heritage.

The Policy should not provide the same level of protection to land outside of the AONB (which could be considered to affect the setting of the AONB), as land within the AONB. This is not justified, nor consistent with National Policy which makes a

clear distinction between development within an AONB and development which affects its setting by stating:

The scale and extent of development within all these designated areas (National Parks, the Broads and AONBS) should be limited, while development within their setting should be sensitively located and designed to avoid or minimise adverse impacts on the designated areas.

(Paragraph 176, NPPF, July 2021)
