1. Introduction

The Infrastructure Funding Statement (IFS) is a report which is published by the end of December each year, outlining both the agreed spend of infrastructure income (CIL and S106) from the previous financial year and also the areas that Stroud District Council will be prioritising for future spending. The IFS replaces the use of the Regulation 123 List in line with the September 2019 amendment to the CIL Regulations 2010 (as amended).

The IFS outlines projects that Stroud District Council intends to be wholly, or partially, funded by Community Infrastructure Levy (CIL) funding. It also includes information on Section 106 (S106) agreements which have been made during the reported year and projects which have been delivered using these mechanisms.

The IFS is written in line with the Stroud District Council Local Plan, a copy of which can be viewed here: <u>https://www.stroud.gov.uk/environment/planning-and-building-control/planning-strategy/stroud-district-local-plan</u>.

This report relates to the financial year 2020/2021.

Changes to the Community Infrastructure Levy (Amendment) (England) (No. 2) Regulations 2019) <u>http://www.legislation.gov.uk/ukdsi/2019/9780111187449</u> has:

- Removed the restriction on pooling more than 5 planning obligations towards a single piece of infrastructure.
- Deletes the Regulation 123 List.
- Allows authorities to choose to pool funding from different routes to fund the same infrastructure, provided that authorities set out in their infrastructure funding statements which infrastructure they expect to fund through the levy and through planning obligations.

Developer contributions can be provided in several ways:

- Community Infrastructure (CIL) a fixed charge levied on new development to fund infrastructure.
- Section 106 (S106) Agreements obligations arranged for Strategic Sites or in instances where the development would otherwise be considered unacceptable.

Affordable Housing obligations are secured solely through the Section 106 mechanism, without funding from CIL. This is in accordance with the CIL Regulations.

2. What is an Infrastructure Funding Statement (IFS)?

An Infrastructure Funding Statement is a document that must be published each year by a "contribution receiving authority". A contribution receiving authority is any authority which issues Community Infrastructure Levy (CIL) notices or receives money from a Section 106 agreement. Town and Parish Councils who have received a proportion of CIL must also produce a report for each financial year.

Authorities that charge CIL have had to produce an annual report on receipts and expenditure from implementation, but there has not been a requirement to report on

Section 106 in this way before now. Reports can be located on the SDC website <u>www.stroud.gov.uk/CIL</u> under "CIL Reporting".

The Infrastructure Funding Statement will cover both CIL and Section 106 planning contributions. The information within the document will relate to all new activity in the year as well as unspent money from previous years.

3. Removal of the Regulation 123 List

The Infrastructure Funding Statement (IFS) will be produced annually and replaces the Regulation 123 List entirely which was removed in the September 2019 amendment to the CIL Regulations. Once the IFS is published, the Regulation 123 List will no longer be used in any spending decision making. Organisations making bids and expressions of interest for funding to the authority must use the IFS as their point of reference.

4. A report on the total amount of CIL income received by Stroud District Council

Stroud District Council implemented CIL on the 1st April 2017, the below table shows the total income received to the end of the reported financial year.

Please note: The IFS mainly focuses on the spending of the Strategic fund. Town and Parish Councils are required to complete an individual annual report for the Neighbourhood Portion; a list of these reports can be viewed <u>here</u>. The CIL Admin amount goes towards the running of the CIL function at Stroud District Council.

6. Projects granted CIL funding in 20/21

Stroud District Council provides an opportunity for Strategic Infrastructure Providers to submit bids and expressions of interest in the Summer of each year for projects they intend to carry out in the following financial year 21/22. Officers make recommendations to committee in the Autumn where the project spend receives final approval.

7. Project update from the previous financial year 19/20

2019 Allocations: River Frome Restoration, Rural SuDS & SVP Tree Planting

The delivery of all three projects were dependent on people being able to meet on site and working alongside each other, so it is understandable that physical works programmed to be undertaken between April 2020 and March 2021 faced significant disruption and delays due to the Covid-19 Pandemic.

These projects are now progressing very well with at least 50% of physical works completed. Full project completion is assured by the end of this financial year March 2022 and all financial commitments are expected to be claimed.

So far, the SVP tree planting scheme has spent £4771 from their allocation.

8. CIL receipts passed to Town and Parish Councils

In the 20/21 financial year, a total of £50,749.57 was passed to Town and Parish Councils where enough CIL had been accrued for their neighbourhood area. The table below shows payments which were made. Councils which appear twice in the table received money in both April 2020 and October 2020 (the two dates as specified in the CIL Regulations).

9. Town and Parish Council project spending

Town and Parish Councils are paid twice yearly in April and October no later than the 28th of the month (as per legislation). With money allocated in previous years, we have been informed that some spending has now taken place via the annual report Town and Parish Councils are required to complete, linked earlier in this report. The following projects have been funded by Neighbourhood CIL (predominantly money has been put towards projects with a larger total cost):

- Cycle Storage at Stroud Train Station (Stroud Town Council)
- Play area equipment (Kings Stanley Parish Council)
- New parish notice board at Great Oldbury (Stonehouse Town Council)
- Parish phone box conversion to a defibrillator (Hamfallow Parish Council)
- Refurbishment of Miles Marling Park (Nailsworth Town Council)
- Installation of toddler play equipment (Painswick Parish Council)
- Children's play area at Sheepscombe Village Hall (Painswick Council)

Nearly all of the Town and Parish Councils with money collected for their area have been in receipt of funding with a few much smaller amounts (less than £200) remaining on account upon request. Since CIL's implementation date on the 1st April 2017, we have collected a total of £184,201.23 in the Neighbourhood Portion and allocated £106,811.99 to the applicable Town or Parish Council.

10. Spending of Administrative Costs

In line with the CIL Regulations, 5% of all CIL receipts are retained by the authority for administrative costs. This portion is spent in full annually by Stroud District Council on the daily running of the CIL function including staffing costs.

The below table shows the total amount of CIL which has been retained by Stroud District Council.

- An exemption is applied for prior to implementation

13. A report on the previous financial year for Section 106 (S106)

Since the adoption of CIL at Stroud District Council in 2017, this has predominantly replaced the use of S106 agreements. However, there are some instances whereby they will still be sought, namely on strategic site applications that have been identified within the Stroud District Council Local Plan (November 2015), or where there is a requirement for affordable housing.

14. Special Area of Conservation (SAC) payments

22. Methodology for Allocation of Infrastructure Funds

Stroud District Council operate an annual funding allocations process for eligible CIL Strategic Infrastructure Projects. Information on the full process, including timescales and guidance notes can be found on the website <u>www.stroud.gov.uk/CIL</u>.

Infrastructure delivery partners, (for example, County Council Education and Highways, as well environmental groups and Emergency Services) are invited to submit project bids in the Summer of each year.

An assessment panel consisting of relevant officers and managers meet in Autumn to discuss the merits of the bids, and assess their relevance to delivering the planning priorities as set in the Infrastructure Delivery Plan (IDP) and the Councils adopted Local Plan. The funding allocations recommended by the panel are then presented to Council's Environment Committee towards the end of the year. Bid applicants are then notified of the funding decisions early the following year and are provided with supporting information on the requirements for subsequent reporting and funding claims.

The planning assessment criteria against which infrastructure projects are measured is set out in the points below. Recommended funding allocations are made depending on the strength of any one project and its ability to meet priority planning needs.

- Does the project fall within the IFS?
- Is the project "Strategic"?
- Does the project deliver infrastructure for schemes either allocated within or in accordance with the Local Plan?
- Is the project within the Local Plan IDP either marked as critical, essential or desirable?
- Is there more recent evidence available to justify the project if it is not within the Local Plan or IDP?
- Is the project supported by the Infrastructure Provider?
- Are there other funding sources available for funding the project?
- Is there a specific trigger or timing required for this project within this financial year?

23. Identified areas for prioritisation of Infrastructure Funding

The Council is currently reviewing governance arrangements to ensure that funding is secured to provide the necessary infrastructure to support future development proposals.

However, the Council will continue to prioritise funding on supporting growth set out in the statutory Local Plan and on other projects supported by more recent evidence. The current adopted Local Plan (November 2015) covers the period to 2031 and is supported by an Infrastructure Delivery Plan (IDP) (2014) which sets out infrastructure required to deliver the development set out in the Local Plan. The Council is currently preparing a new draft Local Plan for the period to 2040. A draft IDP (2020) sets out the expected infrastructure requirements to support these future growth proposals.

Development proposals will continue to be supported by S106 contributions and CIL in line with the arrangements for introducing CIL set out in the Charging Schedule (February 2017) and other policies.

The broad infrastructure categories to be funded, or part funded, through CIL previously identified within the Council's Reg.123 List remain relevant.

The table provided in **Appendix E** gives a list of identified areas for prioritisation of future funding.

24. Identified projects for future funding

Stroud District Council has received expressions of interest (EOI) for infrastructure projects to be delivered in the near future, but were not yet in a position to proceed as a formal bid in previous CIL bid funding rounds. The below table lists these projects.

It is important to note that these projects have not been scored or assessed against the CIL assessment criteria and in no way illustrate any level of support or planning priority.

This list is also an illustration of the projects that have expressed an interest in gaining CIL funding support up until December 2021. There are likely to be further projects in development that are yet to make us aware of their project needs and funding intentions.
